Qualifications and Experience:

I. A Master's Degree with at least 55% of the marks or its equivalent grade of 'B' in the U.G.C. 7 point scale. The condition of 55% of marks at Master's level is relaxable in case of applicants who are already in the University system.

A relaxation of 5% from 55% to 50% of the marks at the Master's level is permissible for S.C/S.T. candidates. A relaxation of 5% from 55% to 50% of the marks is permissible to the Ph.D. Degree holders, who have passed their Master's Degree prior to 19th September, 1991.

II. At least 15 years teaching experience as Lecturer (Senior scale) / Lecturer with 8 years experience in Reader's Grade along with experience in educational administration.

OR

Comparable experience in research establishment and/or other institutions of Higher Education.

OR

15 years of Administrative Experience, of which 8 years shall be as Deputy Registrar or an equivalent post.

III. (a) Computer Awareness:-

The candidate should have basic knowledge of computer. The Govt. of Gujarat has declared curriculum mentioned in General Administrative Department resolution dated: 13/08/2008 no. CRR-10-2007-120320-G.5 and its enclosure -1, as required basic knowledge of computer. The computer certificate of above mentioned curriculum from any reputed institute will be valid. In addition, any certificates of any Degree or Diploma computer course from any University or Government approved Institute or any degree or diploma course which included Computer as subject or passed of Std-10 or Std.12 with computer subject will be valid. The candidate who does not have such computer certificate can also apply for the post, but he/she will have to furnish such certificate before appointment. The candidate who does not have such qualification will not be qualified for appointment.

- **IV.** Ph.D. shall be desirable qualification.
- V. Proficiency in Gujarati.

- (1) Maximum age limit is 50 years as on last date of submission of application.
- (2) "B" in the 7 point scale with letter grades O,A,B,C,D,E, & F shall be regarded as equivalent of 55% wherever the grading system is followed as prescribed by U.G.C.

- (3) Application(s) made on **plain paper** shall not be entertained under any circumstances, whatsoever. Also, applications received by **E-mail & Fax** shall not be entertained.
- (4) Those who are in service should apply through proper channel.
- (5) Applicants who are in the employment shall route their application through their employer. However, in case of an "anticipated delay" such applicants may submit an advance copy of their applications. In the event of applications duly forwarded by the employer, not reaching the Registrar within the stipulated time, the applicant concerned shall be required to furnish a "No Objection Certificate" from his/her Employer, at the time of Interview, in absence of which he/she shall not be permitted to appear for the interview.
- (6) Incumbents shall be entitled to new pension scheme benefits as per rules prescribed by the Govt. of Gujarat from time to time.
- (7) Post carry usual allowances and benefits as admissible under University rules in force from time to time.
- (8) Five copies of the application form alongwith attested true copies of the relevant enclosures to all the Five Copies shall be submitted alongwith copies of application form, failing which it will be treated as rejected. Attested copies or reprints of testimonials will not be returned. Original documents will have to be produced at the time of interview.
- (9) All copies of application form should be filled in by the candidates in his/her own handwriting. Xerox copies of the application shall not be entertained.
