The Dendayal Port Trust (formerly known as Kandla Port Trust) is a vibrant, world-class multicargo Port offering services at multiple locations and having a dominant share of regional cargo by virtue of its ability to effectively leverage its locations and land resources for facilitation of growth of economic activities and investments, with the objective of developing mutually beneficial and sustainable linkages with port based industries and users, thereby, making Kandla the driver of economic growth in the region and India.

The Deendayal Port Trust invites applications from eligible and competent persons for engagement as Stenographer (English) purely on contractual basis as under:

Name of the Post: Stenographer (English)

Number of Posts: 02 (Two)(UR)

Qualification - as under:

- (i) Graduate having sufficient knowledge in computer in Office Automation Software like MS Office applications with six months' certificate course in computers.
- (ii) Should have a speed of 80 w.p.m. in shorthand in English and 40 w.p.m. typing speed on computer.

**Experience:** Preference shall be given to those who have proficiency both in English and in Hindi Stenography and typing on computer. Proficiency in Stenography and Computer Operation shall be judge through shorthand test and test on computer in MS Office Applications.

Type of Employment: Purely contractual.

**Tenure of contract:** Eleven months from the date of joining, extendable for one more term based on the performance and requirement.

Remuneration: Fixed Rs. 32,000/- (Rupees Thirty-Two Thousand Only) per month.

### **General Instructions / Conditions:**

- 1. Only Indian Nationals are eligible to apply. While applying for the post, the applicant should ensure that he/she fulfills the eligibility criteria and other norms mentioned above.
