### **Terms and Conditions:**

- Selected candidate has to do field survey work in Western India (Gujarat, Rajasthan, Maharashtra and Goa) as assigned by Co-Principal Investigator.
- The survey period comprises two visits i.e. December, 2020 to January, 2021 and June-July, 2021 and information is to be collected from same respondents two times.
- During field survey interviewer is to collect information from different stakeholders like milk producer, consumer, milk vendor, dairy industry, creameries, halwai and commercial dairy farm.

1. Roles & Responsibilities: **S. D. Agricultural University, Sardarkrushinagar, District Banaskantha** would be the project holder and contact point for **ICAR-National Dairy Research Institute, Karnal** (Funding organization) while \_\_\_\_\_ (name of Field Investigator) would be the Field Investigator.

A. **S. D. Agricultural University, Sardarkrushinagar, District Banaskantha:**

- i. Will be the sponsor and owner of the project
- ii. Will provide financial payment to Field Investigator and as per Agreement / Plan
- iii. Will conduct periodically review progress against milestones
- iv. Technical support the Field Investigator on need basis as and when required
- v. **S.D. Agricultural University** solely reserves the rights to use the data and Field Investigator has no right to use the data in any form.

Collection of data from a minimum of 80 Households and fill it in printed questionnaires.

2. Term: The term of this Agreement will come to an end on 31st July, 2021.

3. Funds: **S. D. Agricultural University, Sardarkrushinagar, District Banaskantha** will receive the fund from **ICAR-National Dairy Research Institute, Karnal**. A part of the available funds related to Collection of data during Field survey and filling up questionnaires of selected villages will be paid to the Field Investigator to carry out the mutually agreed deliverables.

4. Consultancy Fee: Total agreed consultancy charges for the services of the data collection are Rs 200/per Questionnaire filled up (inclusive of the travel, lodging and boarding expenses) and verified by the team leader. He should have to fill up minimum eight (8) questionnaires per day. The single questionnaire is to be filled from same household at two visits namely Visit-1 will start from December, 2020 to January, 2021 and Visit-2 comprises June, 2021 and July 2021 survey period.

5. Disbursement of Consultancy Fee:

The part of payment (50 %) for Visit-1 will be paid after submitting visit-1 questionnaire and after scrutiny of it and part of payment (remaining 50 %) will be paid after submitting visit-2 questionnaire and after scrutiny of it.

6. Work of Field Investigator:

- Collect Data from the allocated number of household/ farmers
- Facilitating Data Entry Operator
- Work assigned by PI/CO-PI
