The Deendayal Port Trust (formerly known as Kandla Port Trust) is a vibrant, world-class multi-cargo Port offering services at multiple locations and having a dominant share of regional cargo by virtue of its ability to effectively leverage its locations and land resources for facilitation of growth of economic activities and investments, with the objective of developing mutually beneficial and sustainable linkages with port based industries and users, thereby, making Kandla the driver of economic growth in the region and India.

The Deendayal Port Trust invites applications from eligible and competent persons for engagement of Consultant(s) purely on contractual basis, for the posts as under:

**Retired Mamlatdar / Deputy Mamlatdar (on contract basis) – Two Posts**

**Eligibility Criteria:** The engagement of retired Government Officers / Officials as Consultant, will be made as per the “comprehensive guidelines for engagement of retired Government Officers / Officials as consultant.” Issued by Government of India.

First preference will be given to the officers (and / or retired officers) having number of years of experience in the vicinity of Bhuj / Jamnagar / Khambhalia region.

**Upper Age Limit:** Maximum 65 years of Age as on the 01/07/2021.

**Type of Employment:** contractual.

**Tenure of contract:** One year extendable as per requirement with the approval of Competent Authority and performance of the Consultant(s).

**Remuneration:** Fixed Rs. 40,000/- (Rupees Forty Thousand Only) per month in case of engagement of Retired Mamlatdar and Fixed Rs. 30,000/- (Rupees Thirty Thousand Only) per month in case of engagement of Retired Dy. Mamlatdar. However, the total monthly remuneration and pension drawn by the consultant shall not be more than the last pay (calculated at current rate of Dearness Allowance), drawn by him.

**Other Facilities:**

- Conveyance Allowance of Rs. 3,000/- per month shall be payable in case the individual is not using Port Vehicle.
- DPT will provide vehicle to visit local Government Offices in Vadinar region and to visit the same in Gandhidham/Kandla region, subject to availability of vehicle.
- No TA/DA will be admissible for joining the assignment or on its completion. In case of travel to Ahmedabad/Gandhinagar or other local territory of Gujarat state in connection with the official work, DA limited to Rs.900/- per day and TA as per the actual amount, limited to 2-Tier AC Fare will be paid, subject to prior approval of the Competent Authority. In case of outstation stay, stay allowance limited to Rs. 2,500/- per day will be granted.
- Suitable Port Accommodation will be provided, subject to availability of the Port Quarters.
- Medical facility will be provided as per rules.
- The engagement of consultants can be terminated as per the comprehensive guidelines for engagement of retired Government Officers / Officials as consultant' issued by the Government of India from time to time.

**Brief Scope of Work:**

- Study the port land revenue maps.
- Listing of survey number village-wise, identification of port land and collecting the corresponding computerized RTCs from Revenue Department.
- Studying the RTC's with the documents/awards available with OOT, DPT/Authority and advising the Authority whether any change of entity is required.
- Collection of FMB Drawings/Sketches/village maps from the concerned officers of Revenue Department and regularizes all land record of Kandla and Gandhidham Land & OOT Vadinar Department.
- Making arrangements to carry out the Boundary survey and fixing the Boundary points by the Authorized Surveyors of the Revenue Department.
- Advising the Authority regarding encroachment of any and procedure to be followed for removal of encroachment.
- Defend and present the case on behalf of DPT in respect of wrongful allotment by State Government on DPT land in New Survey No. 155/1 with the Collector through Port Advocate and Port Officials.
- Assist DPT officials on survey, demarcation and fixing of waterfront areas of DPT boundaries long 110 kms (18 villages) with DILR.
- Any other work assigned by DPT from time to time. However, he will directly report to Chief Engineer, DPT.

The engagement will be purely contractual for one years, extendable as per requirement with the approval of the Competent Authority and performance of the Consultant(s).

**General Instructions / Conditions:**

1. Only Indian Nationals are eligible to apply. While applying for the post, the applicant should ensure that he/she fulfills the eligibility criteria and other norms mentioned above. In case, it is detected at any stage of recruitment that a candidate does not fulfill the eligibility norms and/or that he/she has furnished any incorrect / false information or has suppressed any material fact(s), his/her candidature will stand automatically cancelled. If any of the above shortcoming(s) is / are detected even after appointment, his/her services are liable to be terminated without any notice.
2. The mere fact that a candidate has submitted the application against the advertisement would not bestow upon him/her the right to be called for the test / interview for selection.
3. Employees retired from Central & State Government/Semi-Govt./ Govt. Autonomous Bodies/CPSEs must submit consent letter at the time of interview.
