GENERAL INSTRUCTIONS TO CANDIDATES AND MATHOD OF APPLICATION TO APPEAR IN WALK IN INTERVIEW

- 1. The number of vacancies may be changed without any prior notice.
- 2. No. TA/DA will be admissible either for the 'Walk- in- interview' or for joining the post.
- 3. The Competent Authority reserves the right to fill up all or not to fill up any post or cancel any vacancy /interview at any stage.
- 4. The selected candidates will have to join stipulated date given in offer of appointment.
- 5. The selection is subject to the candidates providing their medical fitness Certificate issued by Medical Board at ESIC Hospital Vapi.
- 6. Candidates must be registered with Medial Council of India before joining the post.
- 7. The candidate who is in the Service should submit "No Objection Certificate" from the employer at the time of interview.
- 8. Candidate seeking reservation benefits for SC/ST/OBC/EWS must ensure that they are entitled to such reservations per eligibility prescribed in the Notice. They should also be in possession of the required certificates in the prescribed format in support of their claim as stipulated in this Notice. OBC candidates should ensure that they are in possession of valid OBC Certificate issued within such issued by the authority mentioned in the format.

- 16. The contractual appointment for part time contractual specialist will be for one year from the date of joining or appointment of regular incumbents whichever is earlier.
