GENERAL INSTRUCTIONS / CONDITIONS:

1. Indian Nationals are only eligible to apply.
2. While applying for the post, the applicant should ensure that he/she fulfills the eligibility and other norms mentioned above. In case, it is detected at any stage of recruitment that a candidate does not fulfill the eligibility norms and / or that he / she has furnished any incorrect / false information or has suppressed any material fact(s), his/her candidature will stand automatically cancelled. If any of the above shortcoming(s) is / are detected even after appointment, his/her services are liable to be terminated without any notice.
3. Relaxation in terms of age etc. as per the Govt. guidelines shall be applicable for the posts reserved for SC/OBC candidates. The reserved category candidates are required to submit the caste certificate in the prescribed format of Govt. of India, issued by the Competent Authority in support of their claim.
4. Should have MBBS degree included in any one of the Schedule – I to the Indian Medical Council Act, 1956(102 of 1956) and must be registered in a State Medical Register or Indian Medical Register.
