(TO BE RETAINED BY THE CANDIDATE)**

1	Processing fee for General candidate is Rs. 1000/- and for candidates belonging to reserve categories i.e., SC/ST/SEBC/PH of Gujarat state is Rs. 250/-. The application should be submitted online from website http://www.ku-guj.org after paying fees through Debit Card/Credit Card/Net Banking or downloading the bank chalan and paying fee in cash in any branch of the HDFC BANK. The application without processing fee will be rejected.
2	Before filling/submitting the application form you are advised to go through the qualifications prescribed for the post (enclosed) and make sure that you possess the same. The reserved category Candidate applying for General (Open) seats will not be eligible for any relaxation in age and qualification. SAU GUJ Employee means employees of State Agricultural Universities of Gujarat.
3	Please make sure that all the entries in this form are filled up. Where not applicable please filled the column as Not Applicable.
4	The application should be complete in all respects i.e. it should be <ul style="list-style-type: none">(i) Filled in completely.(ii) Supported with self-attested copies of all academic, experience certificates, caste (if required) and other certificates.(iii) Routed through proper channel (in case persons already employed)(iv) If all or any of above are not fulfilled the application will be rejected.

5	FILLING THE FORM:	
5.1	When you apply for more than one post you should submit a separate application for each post and separate processing fees.	
5.2.1	Documentary proof in support of previous experience and academic qualifications indicated in the application should invariably be sent along with the application, failing of which shall mean to believe that you do not possess the experience and qualifications mentioned therein and the application shall be treated as incomplete and will be rejected. For teaching posts Academic Performance Index (API) form must be filled in.	
5.2.2	Degree / Diploma Computer basic knowledge certificate from University / Institute recognized by the State Government or proof of computer as one of the subject in 10th and 12th should invariably be sent along with the application, failing of which shall mean to believe that you do not possess the experience and qualifications mentioned therein and the application shall be treated as incomplete and will be rejected.	
5.3	For teaching, posts the most important entries in this form are details of academic qualifications, list of publications, teaching, research, extension experience and your employment record; Please make sure that all the details are given in the form in which they are asked for.	
5.4	Along with the application form, A blank " SUMMARY FORM " in which you are required to give a summary. The summary form in ten copies should be submitted with duly filled application form. The information asked for under the different columns should be brief but complete.	

	5.5	With reference to your publications, please give details of title of papers on separate sheet. Please note that the titles of the publications are not to be lumped together but classified as original research papers, text books, reports, bulletin, conference or seminar papers, extension literature, etc. Also please note that you are to mention only those which have been published or printed through you may give reference to papers which have already been accepted for publication by a Journal.
6		A recent pass-port size photograph and signature should be uploaded with the application.
7		Fee: The fee is non-refundable.
8		To avoid delay in the receipt of application through proper channel the candidates are advised to submit an advance copy of their application (complete in all respects) before the last date of submission. However, the application through proper channel must reach within fifteen days of the closing date. SUCH APPLICATION RECEIVED AFTER PERIOD OF FIFTEEN DAYS SHALL NOT BE CONSIDERED.
9		The Kamdhenu University employees/teachers should submit their applications to their respective Heads of Departments at least ten days before the closing date for receipt of applications through their University Officer concerned.
10		In case of SC/ST/SEBC/PH Certificate issued by competent authority of Gujarat State attested by self should be enclosed. In case of SEBC candidate Non-Creamy Layer Certificate for the current year (2016-17) should be enclosed along with the application, otherwise he/she will not be considered against SEBC category.
11		The application must reach the Registrar on or before the last date prescribed <u>19/11/2016</u> for receipt of applications in the advertisement APPLICATIONS RECEIVED AFTER THE LAST DATE SHALL STAND REJECTED AUTOMATICALLY.
